Conditions of Use for Service Providers

_____, as responsible for the Service Provider(s) identified in this document express their willingness of using the identity federation services offered by the *RedIRIS Identity Service* and declares that:

1. Knows and accepts the rules, procedures and technical requirements for their connection with the RedIRIS Identity Service, as specified at <http://www.rediris.es/sir/> . Applicants accept the appropriate changes that may take place, and that shall be communicated with sufficient time through the service website, and directly to the technical contacts designated in this document.
2. Knows that breaking these conditions can imply the discontinuation of the service.
3. Declares that data included in this document are accurate, apart error or omission in good faith.
4. Commits to keep updated the information included in this document, informing the service responsible of any change.
5. Commits to accept the metadata provided by the RedIRIS Identity Service for the applicable protocols through <http://www.rediris.es/sir/> and to update them on a periodical basis, as well as whenever such update is requested by the service operators.
6. Commits to accept the identity attributes identified at the end of this document, as well as to process them in strict accordance with the laws and regulations pertaining personal data processing.
7. Assumes that RedIRIS, in all procedures related to service provision, will act according to the data provided in this document.
8. Knows and accepts that once the service is active it can be revoked in case of violation of the requirements or serious technical negligence.
9. According to their best knowledge, the use of the RedIRIS Identity Service by the service providers described here does not violate any right of third parties.
10. Knows and accepts that the service is provided by RedIRIS in non-commercial terms for its users in the research and academic community, and that RedIRIS shall not be held liable for any damage caused, directly or indirectly, by the usage of the service.
11. Knows and assumes that RedIRIS will perform personal data processing according to Ley Orgánica 15/1999 on Personal Data Protection and the regulations developing it.
